 - Orders can be placed by calling 1-888-628-2770 (TTY: 711). They can talk to an agent Monday to Friday, from 9 AM to 8 PM local time. They'll need their member ID to place the order.

When using this benefit in store

When using the benefit in-store:

1. The member goes to a participating location
 - An enabled store will have blue labels on the shelf to indicate eligible products. Some enabled stores will have a designated shelf for eligible products and a digital catalog in the store.
 - They can also use the catalog to find products or plan their trip ahead.
2. The member chooses eligible products and brings them to the register.
3. They present their Aetna® member ID card and tell the cashier their date of birth. Then the cashier will apply the allowance to their total.
4. If there is a remaining balance, they can use another form of payment to complete the purchase. If the member is on a qualified high deductible health plan, they can use any Health Savings Account balance to purchase eligible items.
